In accordance with directives from UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in higher Educational Institutions, 2009 an Anti-Ragging Cell has been constituted in this College to prevent ragging and to take anti-ragging measures.

What is Ragging:

- Any disorderly conduct whether by words spoken or written or by an act which has the
 effect of teasing, treating or handling with rudeness on any other students.
- Any disorderly behavior that annoys others makes life difficult, caused physical or mental injury or makes junior students fearful or anxious about it.
- Any performance that requires the students to do something unusual that has the potential to make them feel ashamed or embarrassed could have a negative impact on their physical or mental health as junior students.
- Use of criminal force, criminal trespass and intimidation, teasing, embarrassment, humiliation, assault, criminal intimidation wrongful restraint or confinement causing great harm; kidnapping, extortion or molestation committing unnatural offence causing death or aiding suicide causes for the increase in the incidence of ragging.

Objectives of Anti Ragging Committee

Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the college Campus. The main objectives of this cell are as follows:

- 1. To aware the students of dehumanizing effect of ragging inherent in its perversity.
- To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
- To promptly and stringently deal with the incidents of ragging brought to our notice.
- To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments

- 1. Debarring from appearing in any sessional test / University Examination
- 2. Suspension from attending classes and academic privileges
- 3. Withdrawing scholarships and other benefits
- 4. Suspension from the college
- Cancellation of the admission
- 6. Withholding the results.
- 7. Cancellation of admission.



- 8. Rustication from the institution for period ranging from one to four semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

Roles and Responsibilities

Every person who is the Principal or the Officer- in - Charge of the College or who is in the service or pay off or remunerated by the College to do any work assigned to him/her in connection with the maintenance of discipline therein, shall be bound to take immediate action on the occurrence of any incidence of ragging and to report it to the anti-ragging squad, the Principal or the "Officer-in-Charge". The report will also include the identity of those who have engaged in ragging and the nature of the incidence. This will include teaching as well as Non-Teaching staff. Non-Teaching staff has to be incorporated in Anti Ragging Squad of the college. Anti-ragging complaints must be handled right away and in the proper manner, regardless of their format or source. The appropriate authorities will also be informed of the action. The complainant's identity will remain private.

Any person who contravenes the above provisions shall, on conviction, be punished with imprisonment for a term which may extend to one year or a fine which may extend to ten thousand rupees, or with both.

When a student, parent, guardian, teacher, member of the non-teaching staff, or officer-in-charge reports ragging to the principal in writing, the principal must, without affecting the preceding provisions, investigate the complaint within 24 hours of receiving it and suspend the offending student if it appears, at first glance, to be true. Where, on enquiry by the principal, it is proved that prima facie there is no substance in the complaint of ragging; he shall intimate the fact, in writing, to the complainant.


Committee Members:
